NOTES:

- ALL CONSTRUCTION SHALL BE PER NCDOT AND THE CITY OF DURHAM STANDARDS, SPECIFICATIONS AND DETAILS.
- ALL DIMENSIONS ARE TO THE EDGE OF PAVEMENT & PROPOSED WIDENING CENTERLINE UNLESS OTHERWISE NOTED.
- CONTRACTOR SHALL RELOCATE AND/OR ADJUST ALL UTILITIES THAT CONFLICT WITH THE PROPOSED ROAD IMPROVEMENTS. EASEMENTS WILL BE REQUIRED AND SHOWN ON PLAN SHEETS WHEN WARRANTED.
- CONTRACTOR SHALL REMOVE, STOCKPILE, AND RESET ANY NCDOT SIGNAGE ALONG HOPSON ROAD.
- THE LOCATION AND SIZE OF EXISTING UTILITIES AS SHOWN IS APPROXIMATE ONLY. THE CONTRACTOR IS RESPONSIBLE FOR HORIZONTALLY AND VERTICALLY LOCATING AND PROTECTING ALL PUBLIC OR PRIVATE UTILITIES (SHOWN OR NOT SHOWN) WHICH LIE IN OR ADJACENT TO THE CONSTRUCTION SITE. AT LEAST 48 HOURS PRIOR TO ANY DEMOLITION, GRADING, OR CONSTRUCTION ACTIVITY, THE CONTRACTOR SHALL NOTIFY THE NORTH CAROLINA ONE-CALL UTILITIES LOCATION SERVICE (U-LOC) AT 1-800-632-4949 FOR PROPER IDENTIFICATION OF EXISTING UTILITIES WITHIN THE SITE.
- REFER TO STORM DRAINAGE SHEETS FOR ALL DRAINAGE DESIGN INFORMATION.
- CONTRACTOR SHALL MILL ACROSS EXISTING ROADWAY TO PROVIDE A MINIMUM 1.5" OVERLAY AT THE LIMITS OF CONSTRUCTION PROVIDING A SMOOTH TIE-IN TO EXISTING PAVEMENT.
- REGRADE AND REPAVE OR PLACE GRAVEL (WHERE APPROPRIATE) TO MATCH CURRENT DRIVEWAY SURFACE CONDITIONS) TO TIE IN EXISTING DRIVEWAYS TO PROPOSED WIDENING. MATCH EXISTING DRIVEWAY WIDTHS.
- POTENTIAL CONFLICT WITH EXISTING WATER BRANCH LINES FOR METER AND HYDRANT. CONTRACTOR TO ADJUST BRANCH LINES DURING CONSTRUCTION.



GROUNDWATER NOTE
 THE PRESENCE OF GROUNDWATER SHOULD BE ANTICIPATED ON THIS PROJECT. CONTRACTOR'S BID SHALL INCLUDE CONSIDERATION FOR ADDRESSING THIS ITEM.

Construction Requirements
 All public and private work including but not limited to watermain, water services, sanitary sewers, sanitary sewer service, storm sewers, drainage systems, roads, sidewalks, parking lots, site grading and landscaping shall be constructed in accordance with the Town of Morrisville and the Town of Cary Ordinances, Standards, Specifications, and Details that are applicable. No deviations from the Owner/Developer's Submittal plans will be allowed unless written approval from the Town of Morrisville is received, along with permission from the Town of Cary for water and sanitary sewer deviations. All Public and Private Easements shall be recorded prior to final acceptance by the Town.

Review Disclaimer
 Should the Town of Morrisville or Town of Cary fail to identify, that the Owner/Developer has not addressed the comments made by either Town, or that the Plans and Specifications are not in compliance with respective Town Ordinances, Standards, Specifications, and Details whether from lack of discovery or for any other reason, it shall in no way release the Owner/Developer of their obligations thereof, nor obligate the Town of Morrisville or the Town of Cary to correct such errors or omissions. Execution of this construction plan by the Review Engineer or Planner for either Town in no way limits the responsibility of the Owner and Engineer of Record with regard to compliance with all Federal, State, and local standards, regulations and/or conditions.

Engineer/Inspector Disclaimer
 The presence of the Town of Morrisville or Town of Cary Engineer or Inspector at the work site shall in no way lessen the Owner's responsibility for conformity with the plans and specifications. Should the Engineer or Inspector prior to, during, or after construction fail to identify or reject materials or work that does not conform with the plans and specifications, whether from lack of discovery or for any other reason, it shall in no way prevent later rejection and correction of the unsatisfactory materials or work when discovered. This is also true if the work has been accepted and is currently being maintained by the Town of Morrisville or Town of Cary. The Owner shall be responsible for correction of all work that does not conform to the plans and specifications.
